## APPLICATION FOR WELL REGISTRATION FOR EXISTING WELL (Well Drilled before Oct. 1, 2010)

District Rule 3.3(a) requires the registration of existing wells that are not exempt under District Rule 2.1:

All existing wells completed before October 1, 2010 that are not exempt under District Rule 2.1 must be registered with the District no later than October 1, 2010. Owners of existing wells completed before October 1, 2010 that are exempt under District Rule 2.1, may, at their discretion, register their wells with the District to provide evidence that the well existed before October 1, 2010, for purposes of grandfathering the well from the requirement to comply with any well location or spacing requirements of the District and any other entitlements that existing wells may receive under the District's Temporary Rules or under permanent rules adopted by the District in the future.
