Note: Pursuant to Section 12 of the District’s Rules, the District is required to hold permit hearings on permit applications and certain permit renewals or amendments. Public notice of permit hearings before the District’s Board of Directors on the permit applications submitted to the District will be posted at a place convenient to the public in the District Office and by the county clerk of Tarrant County on a bulletin board at a place convenient to the public in the county courthouse.

Amendment of Permits: Rule 5.7 of the District’s Rules establishes that a permit amendment may be made only after application to and approval by the District. A major change to a permit includes, but is not limited to, a change that would substantially alter the size or capacity of the well, an increase in the annual quantity of groundwater authorized to be withdrawn, a change in the purpose or place of use of the water produced, or a change of location of groundwater withdrawal, except for a replacement well, and any other change that is not a minor amendment. A major amendment to a permit shall not be made prior to notice and hearing pursuant to Rule 5.7(b) of the District’s Rules.
